Teamsters Local 202, representing 7,500 active Teamster members and Retirees from New York, to California, is proud to endorse Vice President Kamala Harris and Minnesota Governor Tim Walz to be the next President and Vice President of the United States of America. Local 202 represents workers in the warehouse, grocery, healthcare, communications, automotive and hospitality industries.

The Biden-Harris Administration has been without any question the absolute most pro-union administration in generations. Whether it was pension relief, changes to the National Labor Relations Board, infrastructure investment, or supporting the Protect the Right to Organize (PRO) Act, the Biden-Harris Administration has always stood with the American worker.

Both Vice-President Harris and Governor Walz have walked the picket line with striking UAW workers and are the only candidates who have shown a serious commitment to the rights of the American worker and the issues that matter most to the labor movement. Governor Walz, a longtime union member, is one of the first Governors to sign a bill that would ban mandatory employer captive audience meetings for workers seeking to organize a union.

In contrast former President Trump has never shown a commitment to the American worker. In an August 12, 2024 interview he praised tech billionaire Elon Musk as they laughed about firing striking workers. Later that week he implied that he would offer Musk a cabinet position. During his time as President, Trump stacked the national Labor Relations Board with anti-worker lawyers and nominated anti-worker Supreme Court Judges. There is no question that Donald Trump and his billionaire friends are a serious threat to the labor movement and the rights of the American worker.

The Local 202 Executive Board has voted unanimously to endorse the only candidates who stand for working people and their families. That choice is Vice President Kamala Harris and Governor Tim Walz for the next President and Vice President of the United States.

Teamsters Local 202 members can be confident that a Harris-Walz administration will continue to be a strong voice for labor unions and working families and we will continue to enjoy the powerful surge in the labor movement we are witnessing now with several successful high-profile victories in organizing and bargaining.
